

F.A.Q. FOR EXTENSION SERVICES

What kind of services are provided by the Extension Services?

The Extension Services offers technical advice on all aspects of horticulture and animal husbandry. Examples include but not limited to planning and infrastructure advice on agricultural holdings, irrigation, nutrition, holding management, soil and water analysis and advice on Good agricultural practices. The services may be provided from the office and through on-site visits as required on a case by case basis.

How may someone make use of such services?

By phone on **+356 22924182 or +356 22924183** from Monday to Friday during office hours from 7.30 till 15.00 between 1st October and 15th June and from 7.30 till 12.00 between 16th June and 30th September.

Through the Mobile App - **Agriculture Extension Services** - that may be downloaded for free from **Play Store** or **iOS**.

By personally visiting the Extension Services Offices at the Agriculture Research and Development Centre, Ghammieri, Marsa from Monday to Friday during office hours from 7.30 till 15.00 between 1st October and 15th June and from 7.30 till 12.00 between 16th June and 30th September.

How long does it take to process and reply a request?

Any request for advice is logged and forwarded to a team of officers who in turn will contact the client within 2 working days for an appointment to discuss, evaluate and provide the requested advice.

Is the service against payment or free of charge?

The Extension Services are provided free of charge. However any expenses related to the given advice such as purchasing of materials, laboratory and professional fees are to be procured and borne by the clients.

What about the privacy of the client?

The Extension Services guarantees the privacy of its clients and no kind of information is divulged to any public or private entity unless by consent of the client.
